Kelipan Raya Setia Bercahaya Open House TERMS AND CONDITIONS

The terms and conditions stated herein below shall govern the **Kelipan Raya Setia Bercahaya Open House** organised by the Organiser ("**Terms and Conditions**"). 2. Name of the Contest
