

**YEAR-END REWARDS DRAW 2022

- 8.3 Each Winner is only entitled to one (1) Prize for the SetiaCation Draw.

- 8.4 The Organiser reserves the right to alter, vary and/or replace the Prize to a prize of similar value at any point of time at its sole and absolute discretion.
- 8.5 The Prize is strictly not exchangeable, not transferable, and not redeemable for cash or in kind.
- 8.6 Outside of Section 8.2, all and any costs and expenses incurred in relation to the SetiaCation Draw and/or the Prize shall be borne fully by the Participant and / or winner(s). The Organiser shall be under no obligation to reimburse the Participants and / or winner(s) for any such costs and expenses incurred thereof.
